# Board Elections History

2009: Frank Cockrell, Larry Shanks, and Steve Rideout (all elected in January 2010)

2010: Judy Pulliam (replaced by Matt Perry in June 2012), Ed Loth (replaced by Bob Jacobsen in April 2012 who was replaced by Dick Gritman in March 2013), and Jim McKevitt (election actually held in January 2011)

2011: Mamie Parker, Donna Stanek, and Bob Stevens (election was delayed until April 2012).

2012: Larry Shanks (re-elected), Jerry Grover, and Gail Carmody.

2013: Nell Baldacchino, Jim Mckevitt, and Matt Perry all elected. Bob Streeter was appointed to replace Bob Stevens who resigned. This appointment expires at the end of 2014

2014: Robin Fields, Mamie Parker, and Bob Streeter elected.

2015: Election cancelled for lack of candidates. Gail Carmody, Jerry Grover, and Larry Shanks all re-appointed to new terms. John Cornely appointed to fill vacancy left by resignation of Robin Fields.

2016: Jim McKevitt was re-elected and Rowan Gould and Skip Ladd elected to new terms of three years each.

2017: Bob Streeter, John Cornely, and Deborah Holle were elected to three-year terms and Robin West was selected to fill the remaining two years of the seat vacated by Skip Ladd.

2018: Cindy Barry, Doug Frugé, and Steve Rideout were elected to three-year terms

2019: No election was needed since only three candidates were running. Robin West, Jim McKevitt, and Nancy Gloman were confirmed to new three-year terms.

2020: Deborah Holle was re-elected and Denise Baker and Paul Tritaik were elected to new three-year terms each.

2021: Jim McKevitt resigned, and Lew Gorman was appointed to a new three-year term as having received the next highest number of votes following Denise Baker and Paul Tritaik in the most recent board election.

2022: Cindy Barry, Steve Rideout and Doug Frugé were re-elected to new three-year terms.
