Memphis 2016 – You Don’t Want To Miss This One But Time Is Running Out!

October is just around the corner, plans for events and speakers at our upcoming reunion have been completed and Memphis beckons like a warm fire and a hot toddy on cold winter’s night.

Yet many of you who would surely enjoy this reunion of your friends and former colleagues have not yet registered or made your hotel reservations. Time is running out and that’s no joke.

Your Board has arranged a fun-packed week at bargain prices. We’ve booked the hotel, developed a full and interesting agenda, scheduled the panels and speakers, set up the tours and events, the music, the socials and the banquet. The rest is up to you. Register for the reunion, make your hotel reservations and your travel arrangements **now** before you miss the opportunity and a memorable gathering.

The City. Located on the mighty Mississippi River, Memphis is a hustling, bustling metropolis that plays host to over 10 million tourists annually, drawn to the city’s and the area’s historic and scenic attractions. Touting itself as the “*Birthplace of Rock ‘n’ Roll and Home of the Blues,*” Visitors flock to Elvis Presley’s Graceland



mansion and to the jumping and jiving Beale Street. Old time paddlewheel riverboats ply the country’s largest and longest

river on tours both long and short. The Memphis Zoo is rated one of America’s ten best (Fodor Travel) and the city has numerous museums and historical sites to visit.

Another attraction is the Memphis Pyramid. This 550,000 square foot wonder is 321 feet tall, the 10th largest pyramid in the world. It is home to the Bass Pro Shops headquarters, a 222,000 square foot Bass Pro Shop store and the Ducks Unlimited Waterfowl Heritage Center, as well as several restaurants, a 100 room hotel and a 28 story free-standing glass elevator to a glass-floored observation deck with the most incredible view of the city of Memphis and the Mississippi River.



Not all of Memphis, however, is a busy city. Away from downtown are large areas of suburban parklands including the vast Shelby Farms Park. This 4500-acre reserve, 5 times the size of New York City’s Central Park, contains several lakes and areas of forest and wetlands that support an array of wildlife. It has well over 10 miles of trails for hiking and biking and even a 56 acre bison reserve. And it’s close to our hotel.



Hotel Reservations. Our venue for this reunion is the Crowne Plaza Memphis – East, conveniently located in suburban East Memphis, an area dotted with parks yet within 15 minutes of most of Memphis’s attractions. The hotel has an outdoor and indoor pool and hot tub, a well-equipped fitness room, free wi-fi, free parking and free local shuttle. We have booked a block of



rooms there at a most reasonable \$99/night lodging rate that includes a cooked breakfast every day. That rate will be honored three days before and for three days after our reunion dates of October 2 through October 6. This will allow you time to plan some side trips on your own.

However, the hotel and many of the surrounding hotels are fully booked for that time period, except for those rooms set aside for our reunion. You must register by September 21st in order to be guaranteed a room at those rates or any other. After that date, rooms will probably not be available at any price.

To make reservations, call the hotel directly at **901-362-6200** and tell them you are entitled to the rate for the “**Reunion of FWS Retirees Association**” and the booking code is **RFW**. You can also make reservations online at the hotel’s website. The link is below. Put your cursor on the link, hit CTRL and click on the



link simultaneously and it should take you to the registration page set up for our reunion.

You will first need to select the dates you want to stay and the type of room (two queen beds or king bed) and the \$99 rate will be displayed. This link is only for our group and for the dates we have negotiated. After selecting your room type, you will need to secure your reservation with a credit card.

Reunion Registration. In addition to making your hotel reservations, you will need to register for the reunion and its events. Again, we have an ambitious agenda replete with nearly a week of activities, tours, and social events **and** we have kept the registration cost to a minimum. The registration fee for our Memphis Reunion is a mere \$115/person. That will cover the evening social with heavy hors d’oeuvres, the banquet (including wine, music and speakers), refuge tour and lunch, transportation, daily coffee and refreshments, and a myriad of other expenses. That’s quite a bargain for four plus days of activities, entertainment and several meals.

The registration fee does **not** include the **Greenwalt Walk for Wildlife and Riverboat Cruise** set up by the Mississippi River Corridor - Tennessee group. The fee for that will be \$30 per person with the proceeds, after expenses, to go to the West Tennessee Wildlife Refuge Complex Friends group.

At the end of this newsletter is a Reunion Registration Form. We strongly encourage everyone to please register before the reunion to be sure that we can provide for you and to help us complete our planning. You can fill it out and send it in by snail mail **or**, if you are among the more technically proficient, you can fill it out and submit it online at our website <http://www.fwsretirees.org/MemphisReunion.html>

Regardless of how you submit your registration form, you can also pay online by using the Pay Pal feature.

Agenda Highlights. A complete copy of the current agenda is appended. This year our reunion focuses on migratory birds and big river fishes but includes other happenings sure to interest FWS retirees **and** their spouses. While many activities are planned, most days will have ample *Free Time* to allow you to do things on your own or with fellow retirees.

Sunday, October 2nd: Registration will commence in the afternoon but the highlight of the day will be the ***Greenwalt Walk for Wildlife and Riverboat Cruise***. We will also have a historian onboard the cruise to tell us stories about the area. This special event has been arranged largely by the Mississippi River Corridor - Tennessee group. The walk is optional but you surely won’t want to miss the one-hour cruise on the Big Muddy with food provided and drinks available. “Old Man River” is calling but you won’t have to “tote that barge” or “lift that bale”. Just sit back and enjoy.

Monday, October 3rd: The official opening of the Reunion and registration will continue. After welcoming introductions and a celebration of the life of Association founding member Denny Holland, we have set up two very interesting and enlightening panels: the first entitled ***Migratory Birds: Celebrating 100 years of the Migratory Bird Treaties*** and the second on the ***National Wetlands Inventory and FWS Wetlands Policy and Management Actions***. We will also have a brief presentation, one of several by your fellow retirees, on interesting things they have undertaken since leaving the active Service. This one will be on a ***Birdwatching Tour of Cuba*** undertaken by several of our Board members. The highlight of the evening will be our ***Social and Reception*** hosted by **Ducks Unlimited** and will include a tour of their headquarters. This was set up by Dale Hall, former FWS Director and current CEO of Ducks Unlimited. Dale has been a great help in our planning for this reunion and we owe him a great debt of thanks.

Tuesday, October 4th: Tuesday’s highlight will be our field trip and tour of ***Hatchie National Wildlife Refuge*** part of the West Tennessee National Wildlife refuge Complex. The field trip will include a barbeque lunch and the opportunity to be a part of a special program for children at the refuge. It will be a workshop on career development and personal development connecting kids to nature. We get back to the hotel in late afternoon and dinner and/or side trips will be on your own.



Wednesday, October 5th: More on the lives of retirees as Jerry and Judy Grover describe their recent *Vacation in a French Polynesian Paradise*. We follow that up with three panels you don’t want to miss. First, Jessica and David Snell from the National Active and Retired Federal Employees (NARFE) and Denise Sheehan and/or Rebekah Giddings from the FWS Office of Human Capital will provide updates and answer questions on ***Retirement Legislation, Policy, and Benefits***. This has always been one of our most popular

presentation and this year should be no exception. Next we expect to have a discussion of *FWS Leadership Highlights and Priorities* with FWS Deputy Director Jim Kurth and Southeast Regional Director Cyndy Dohner. There's a lot that has happened since we met at Corpus Christi and we're sure you want to hear and ask questions of those in charge. Finally, after lunch we will have another great panel, this one on *Big River Fishes* where you will hear about FWS priorities and fishery resource issues along the lower Mississippi River.

On Wednesday evening, we will have our traditional *Retirees Banquet and Silent Auction*. Before and during the Banquet, music by a local jazz combo will be provided. Our after-dinner speaker will be Mark Plotkin, noted ethnobotanist, author and co-founder of the Amazon Conservation Team, whose lengthy career in the Amazonian rainforest has won him renown, including a presentation by Jane Goodall of the award for International Conservation Leadership. And as usual, our *Silent Auction* will have a good many items of value to us fish and wildlife types, so be sure to bring your checkbooks. This is one of our most important fundraising events.

Thursday, October 6th: Wrap-up and closeout day. For those sticking around after the closeout, we are working on arrangements for an afternoon at the Memphis Pyramid. This 550,000 square foot building is 321 feet tall, the 10th largest pyramid in the world. We are proposing lunch on your own at the 'Pyramid' and shopping/sightseeing where ever your feet decide to take you. Resource Issues

In this edition, these will be intentionally very brief and not a complete rundown of issues in order to focus primarily on the reunion. More detail in our next newsletter..

Gray Wolf. Washington state wildlife officials plan to exterminate a pack of 11 endangered gray wolves – six adults and five pups - after the animals were determined to have been preying on cows. There are only 19 confirmed gray wolf packs in all of Washington state, comprising just 90 wolves, according to a June census by the state Department of Fish and Wildlife. Killing the so-called Profanity Peak pack would remove more than 12 percent of the confirmed state population.

Mexican Wolf. In our February newsletter, we reported on the controversy surrounding FWS plans to release additional captive-bred endangered Mexican wolves into New Mexico to increase the gene pool and aid in recovery. New Mexico refused to issue a permit for the release and in late May a federal judge issued a temporary injunction halting the release until FWS obtains said state permit. That's not likely to happen.

In other action, New Mexico congressman Steve Pearce (R-Hobbs) added an amendment to a House appropriations bill last

that, if signed into law, would cut all funding from the Mexican Gray Wolf Recovery Program. Countering this, U.S. Senator Martin Heinrich, D-N.M. proclaimed that the anti-environmental language in the bill was part of a "pattern of very problematic anti-conservation riders," over the last few years in the House and that he would work with U.S. Senator Tom Udall, D-N.M., to ensure those amendments are removed from the final bill.

Bald Eagle Deaths in Maryland. As we reported in May, thirteen bald eagles were found dead in a field near Federalsburg on the eastern shore of Maryland and it was subsequently determined that the cause was poisoning. However, FWS investigators have been unable to identify the culprit(s) for lack of evidence and the case will soon be closed.

If you were caught up in a reorganization, retired from another agency, or took on a second career, but still consider yourself part of the FWS family, you are an eligible retiree.

Among these are colleagues that were formerly in Research, Animal Damage Control, or certain National Fish Hatcheries transferred to State operation
